2009 Annual Reporting

Another big THANK YOU to all Partners who submitted 2008 annual reduction reports or new baselines last year! The total reductions were over 55,000 lbs of VOC and NOX!

25% of Partners submitted new '08 baselines. A few others had increases in employee total and fuel/energy usage which accounted for a lower total than usual, but emission reductions are expected to be greater in 2009 and beyond.

We look forward to reporting and recognizing Partners in 2010 for their new emission reduction successes! As a reminder, Partners can submit their 2009 data at any time between January 1st and August 31st of this year. Submitting data early may be helpful since many of you may be busy with ozone season efforts.

EPA to Strengthen Ozone Standard

On January 7th EPA announced a range for the proposed new ozone standard. The current standard is 0.075 parts per million (ppm) and EPA is proposing to set the "primary" standard protecting public health at a level between 0.060 and 0.070ppm measured over eight hours. The final standard will be issued on August 31, 2010. Details are linked below.

Central Texas measured 0.075ppm in 2009, just in attainment of the current standard. In light of the future standard, larger reduction efforts by Partners are highly encouraged this Ozone Season (April 1st - October 31st). Partners can play a critical part in helping to protect Central Texas' public health by keeping ozone levels at a minimum.

Incentive to kick driving habit in Austin

Tired of driving Austin's congested roads during morning or evening rush hour? Want a more enjoyable ride to work with coffee and breakfast tacos? How about a program that permits employees to use their own pretax dollars to commute in plush, private vans fitted with flat screens and Wi-Fi or ride on Capital Metro's Red Line when it opens?

The so-called commuter tax benefit is getting a lot of attention since Congress raised the amount of pretax money employees can use to pay for mass transit and van pools. Under the economic stimulus package that President Barack Obama signed into law a year ago, employees enrolled in the system can use up to \$230 a month in pretax dollars to pay for mass transit – up from \$120. (There is a \$20 per month allowance for bicycles.)

That is a big incentive for Austin residents to shed their vehicles and reduce pollution. The program is popular with California-based Google, Washingtonbased Microsoft and Yale University in Connecticut. And Austin groups are starting up an innovative transportation pilot that could change the way employees commute.

The big question is whether Central Texans will park their vehicles to ride in customized vans while someone else does the driving. Robin Rather, CEO for Collective Strength, a company that focuses on sustainability projects, believes they will, given the right circumstances. We agree.

"The reason people don't use public transportation is convenience and accessibility," she said. "There isn't a convenient way to get to the job or downtown."

So Rather's company is working with the Environmental Defense Fund and the Clean Air Force of Central Texas to run customized shuttles along routes that make it super convenient for commuters to jump on and ride to job locations.

Veolia Transportation has agreed to run the shuttles. The company recently was released from its contract to run Capital Metro's Red Line rail service but still works with the transit agency's bus system.

Rather and company envision an express shuttle system that would be available to Travis County and City of Austin workers and a few private companies in the beginning. To be successful, Rather said shuttle vans would make one to three stops on each trip (including drop-offs at work sites). Transportation for commuters who need to keep appointments after they've arrived at work also would be available using e-mail or texting to summon shuttles.

Employees would be able to eat food, drink beverages, watch satellite television, check e-mail or relax on the shuttle buses that would cost between \$6 and \$12 a day per person. And commuters could use tax-free money to pay for that convenience. The program is similar to federal flexible spending accounts that permit employees to pay for qualified health expenses with pretax dollars. Like that program, the commuter tax benefit must be set up by employers.

If used for public transportation, it could help reduce transportation costs and air pollution, said Jim Marston, regional director of the Texas Office for the Environmental Defense Fund and chairman of the Clean Air Force board. In the past few years, Austin has come close to violating federal clean air standards, Marston said.

Because the commuter tax program is aimed at getting more vehicles off the road, it could help reduce pollutants caused by cars and trucks, the largest single source of ozone pollutants in Travis County.

If convenience is keeping Central Texans in their cars and trucks, then this is a transportation system that could break that habit.
